Members Declaration

I agree to abide by the rules and conditions of membership displayed in the facilities.

All equipment should be used with care and consideration. Indoor none-marking (not black soled) squash shoes must be worn on the courts. **NO EXCEPTIONS**

I understand that failure to do so may result in the termination of my membership, forfeiting monies that have been paid.

I will only use the club car park when using the facilities or booking a court. The club relies on all-day parking as a source of income. Day time use of the car park is monitored on a regular basis. Your car park sticker should be displayed clearly.

I confirm that I have read the 'Physical Activity Readiness Questionnaire (PAR-Q).

I know of no reason why I should not use the gym and sauna or use the squash/racketball courts or table tennis.

I will not exercise if I feel unwell and that if my health changes, I will inform my doctor or seek medical advice, urgently if necessary.

No member may use the sports facilities whilst under the influence of alcohol or recreational drugs.

I am aware that protective eyewear is recommended to be worn when participating in Squash or Racketball/Squash 57. Should I choose not to wear appropriate eyewear then I accept full responsibility for any injury I might sustain.

I understand that I will be using the facilities entirely at my own risk and waive any legal recourse for damages to myself or property arising from my participation.

I agree that Juniors (under the age of 16y) using the facilities will be always supervised by a responsible adult.

Members using the gym, should be considerate to others and use their own towel to wipe down equipment after use. Free weights etc. should be returned to the correct storage areas after use. Any damaged or faulty equipment should be reported to Mark Sissons, (or any Squash Committee member) as soon as possible.

I will abide by restrictions necessary to maintain a 'COVID secure' environment within Worksop Squash Club. I understand that existing guidance may change, and members will be advised accordingly.
